ARTIST PERFORMANCE CONTRACT - *Fête de la Musique*

1. Location: The Arts Council of Greater Kalamazoo will determine the best venue for your performance no later than Wednesday, June 11, 2008.
2. Date of Engagement: June 21, 2008
3. Set Time: The Arts Council of Greater Kalamazoo will determine the best set time for your performance(s) based on your requested times and the times of other musicians. Your requested set time may not be the time you request.
4. Type of engagement: Family-friendly music, minimum of 30 minutes in length
5. Compensation: All musicians will play without compensation
6. Merchandise: The Arts Council of Greater Kalamazoo is not responsible for any lost, stolen, or damaged merchandise (musicians and/or artist group) at said event.
7. Equipment: Artist agrees to provide all equipment needed for a successful performance. This includes, but is not limited to, amp(s), microphone(s), cable(s), musical instrument(s), all P.A. equipment, and extension chord(s).
8. Weather: In the event of in climate weather all outside venue performances will be either suspended until weather permits the continuation of the event or cancelled for the remainder of the event.
9. Media: The Arts Council of Greater Kalamazoo reserves the right to use videos and pictures of your (musicians and/or artist group) performance.
10. The Arts Council of Greater Kalamazoo is not responsible for accidents, equipment failure, riot, Act of God, or any other events that causes damage to your body or your equipment.
11. Artist hereby releases The Arts Council of Greater Kalamazoo, its officers, directors, employees, or agents from any liability or claim of injury or damages which maybe made by any person for any reason whatsoever, and which claim or claims arise from the terms of or performances under this agreement.
12. The Arts Council of Greater Kalamazoo shall at all times have complete supervision, direction and control over the artist engagement and expressly reserves the right to control the manner, means, and details of the performance of services by the artist as well as the ends to be accomplished.
13. The Arts Council of Greater Kalamazoo shall obtain any special permits necessary to comply with all ordinances and regulations of the municipality or required agreement in which the attraction is presented.
14. The parties hereto acknowledge and agree that the written terms of this contract comprise the entire agreement between the parties, and that no party has relied upon promises representations not contained herein.
15. All parties (musicians and/or artist group) must be on time for their engagement. In the event of a cancellation The Arts Council of Greater Kalamazoo must be notified no later than Monday, June 16, 2008.
